
THANK YOU FOR YOUR INTEREST IN OUR HOMELESS V.E.T.S. PROJECT. I HAVE ENCLOSED A CONCEPT SHEET FOR YOU TO LOOK AT.

DUE TO THE DELAY TIME (2-14 DAYS) IN THE SYSTEMS PROCESSING, HOMELESS VETERANS CONTINUE TO BE FOUND UNDER BRIDGES, IN CARS, GARAGES OR BY RAILROAD TRAQCKS. AS YOU MAY KNOW APPROXIMATELY TWO MONTHS AGO A BROTHER WAS FOUND FROZEN IN HIS SLEEPING BAG... WITH A VOUCHER IN HIS POCKET WAITING FOR PROCESSING TO A SHELTER.

IN MY CAPACITY AS SERVICE OFFICER, I HAVE GONE TO MANY MEETINGS THROUGHOUT THE STATE DEALING WITH THIS SAD ISSUE. THE SAME STATEMENT KEPT COMING UP... "THERE IS NOTHING WE CAN DO UNTIL EACH PERSON IS PROCESSED!" THIS WAS VERY UNSETTLING TO ME AS I BELIEVE THERE IS A SOLUTION TO ANY PROBLEM... SOMETIMES YOU JUST HAVE TO THINK OUTSIDE THE BOX!

IN TROUBLE SHOOTING THE V.E.T.S. PROJECT SOME OF THE ISSUES THAT HAVE BEEN IDENTIFIED INCLUDE: COST, SIZE, IDENTIFYING THE BASIC NEEDS (SAFE, WARM, COMFORT AND ABILITY TO PREPARE A MEAL), MOBILITY, ELECTRIC HOOK-UP. IN COMPLETING THE PROTOTYPE, I HAVE IDENTIFIED THAT A SMALL CARGO TRAILER CAN BE TORN DOWN AND REFITTED WITH THE NECESSARY INSULATION, ELECTRIC WIRING AND PROPANE HOOK-UP. FURTHER REWORKING USING F.R.P. PANELS, LED

LIGHTS AND OUTLETS, BASIC CARPENTRY SKILLS AND ADDING WINDOWS HAS PRODUCED A VIABLE MOBILE SHELTER THAT CAN BE USED TO TEMPORARILY SHELTER A VETERAN FOR THE TIME PERIOD NECESSARY, WHILE MORE PERMANENT HOUSING IS IN THE WORKS.
